The Center has elected to account for the funding as a conditional contribution by applying Accounting Standards Codification (ASC) Topic 958-605, Revenue Recognition. Under ASC Topic 958-605, revenue is recognized when conditions are met, which include meeting FTE and salary reduction requirements, incurring eligible expenditures, and the forgiveness application has been submitted and approved. The Center anticipates using all of the proceeds to make eligible payments, and therefore, expects substantially all of the loan will be forgiven. As of June 30, 2020, all of the conditions not yet met and therefore, revenue not recognized. Expenses incurred related to the funding totaled \$522,063 and \$552,937 in fiscal years 2020 and 2021, respectively. PPP loans are subject to audit and acceptance by the U.S. Department of Treasury, Small Business Administration, or lender; as a result of such audit, adjustments could be required.</p>
