FHR FOCUSES ITS EFFORTS ON IMPROVING THE QUALITY OF LIFE IN THE HOPE VILLAGE NEIGHBORHOOD THROUGH THREE MAJOR PROGRAMMATIC AREAS: SUSTAINABLE, AFFORDABLE HOUSING AND NEIGHBORHOOD CLEANUP. FHR REHABILITATES HOUSES TO CREATE SUSTAINABLE, AFFORDABLE HOUSING. IT ALSO ACQUIRES AND ASSEMBLES PROPERTY FOR HOUSING REDEVELOPMENT, INCLUDING PROPERTY FOR THE VILLAGE OF OAKMAN MANOR, A 55-UNIT SENIOR HOUSING DEVELOPMENT AND OAKMAN PLACE, A 24-UNIT LOW INCOME HOUSING DEVELOPMENT. THIS YEAR, FHR COMPLETED RENOVATION OF AN ABANDONED, FIRE-DAMAGED TWO FAMILY FLAT THAT IT HAS RENOVATED TO THE HIGHEST STANDARDS OF ENERGY EFFICIENCY - THE LA SALLE ECO-DEMONSTRATION HOME. IT ALSO COLLABORATED WITH LIFE REMODELED AND ACCESS FOR ALL TO CLEAN ALLEYS THROUGHOUT THE HOPE VILLAGE. FRESH AND LOCAL FOOD SYSTEMS AND NEIGHBORHOOD ECONOMIC DEVELOPMENT. FHR ASSISTS WITH THE DEVELOPMENT OF LOCAL FOOD SYSTEMS, INCLUDING COMMUNITY GARDENS AND ALSO HOSTS A SEASONAL WEEKLY FARMERS MARKET (WITH FOOD ASSISTANCE) TO PROVIDE A LOCAL SOURCE OF FRESH VEGETABLES AND FRUITS.
