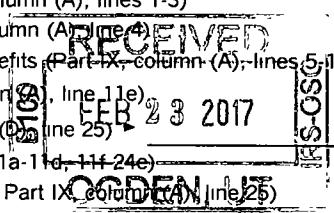

Safe Place is an emergency shelter providing food, clothing, shelter and health evaluations for children removed from their homes due to abuse, neglect or incarceration of the child's caregiver. Safe Place served over 273 children during the fiscal year.

Village Impact Project provides community outreach events to strengthen and connect the community. The goal is to support children and families before situations escalate to abuse and neglect. Village Impact served 1,867 individuals during the fiscal year.

Selah Homes are Hand in Hand's licensed short term foster homes which care for and assess the needs of children entering the foster system for the first time. Currently we have 8 licensed homes and 32 children were served in these homes during the fiscal year.
