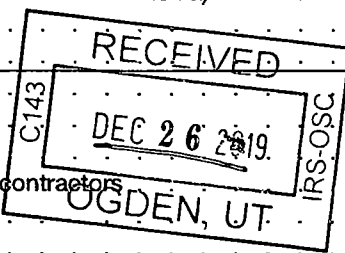



Indiana Parenting Institute, Inc., (IPI) is a nonprofit organization. Our core parenting education and family support services program is called ParentingBirth2Eighteen (B2E). We are committed to educating and developing culturally relevant parenting and family management skills and supports to under-resourced families challenged by the complexities of care and nurturing minor children into productive adulthood. We work in collaboration with our community partners as it is our goal to empower our program participants with the skills need to not only care for self, children, and family but to provide as many opportunities as possible to connect them with key services including technical training, and education to help them move into more stable living behaviors and conditions.

All funds awarded, donated, or contracted through the agency is used for the sole purpose of exercising and achieving the mission of the organization, i.e., to educate, engage, and train parents and the community in advocating for the wellbeing of children and families to prevent child abuse, neglect, and harm and other social ails that stem from this measure of neglect such as teen pregnancy, substance abuse, poverty, youth incarceration, neighborhood deterioration, school dropout, and criminal behavior, across family generations.
