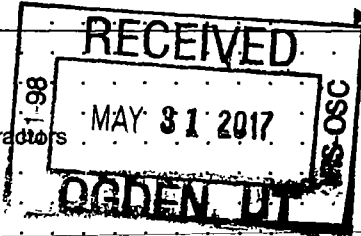

Our program gives personal care items to low income families and individuals in Union County, Ohio. These are items that can't be purchased with food stamps. Items include, but are not limited to laundry detergent, shampoo, tooth paste and brushes, toilet paper, paper towels, deodorant, bar soap, dish soap, cleaning items, male and female in continence products, diapers, and wipes.

We serve approximately 500 individuals per month, including senior citizens, disabled adults, families, children, and those in recovery programs for drug, alcohol, and mental health issues.
