WE PROVIDE ADULT AND FAMILY MEDICINE, WOMEN'S AND SEXUAL HEALTH, PEDIATRICS, BEHAVIORAL HEALTH, NEUROLOGY, OB/GYN, DENTAL, EYE CARE, AND PODIATRY SERVICES. WE ALSO OFFER OPIOID AND OTHER SUBSTANCE USE TREATMENT SERVICES. OUR SOCIAL SERVICES INCLUDE: NUTRITION, EXERCISE AND HEALTHY COOKING PROGRAMS FOR ADULTS AND CHILDREN, A COMMUNITY GARDEN, FREE TAX PREPARATION, A FRESH TRUCK PARTNERSHIP PROVIDING YEAR-ROUND ACCESS TO AND VOUCHERS FOR FRESH FRUIT AND VEGETABLES.
