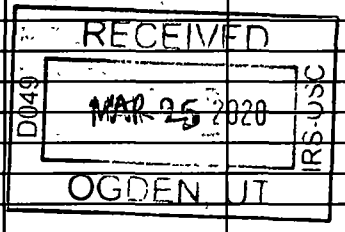

THE TAXPAYER IS FILING THIS AMENDED RETURN TO REQUEST A REFUND OF PARKING TAXES PAID. THIS AMENDED RETURN IS FILED IN ACCORDANCE WITH IRS INSTRUCTIONS AND INTERNAL REVENUE CODE SECTION 512(A)(7) AS REPEALED.
