The Organization is exempt from federal income taxes under section 501(c) (3) of the Internal Revenue Code and therefore has made no provision for federal income taxes in the accompanying financial statements. In addition, the Organization has been determined by the Internal Revenue Service not to be a "private foundation" within the meaning of Section 509 (a) of the Internal Revenue Code. There was no unrelated business income for the nine months ended September 30, 2018.

The Organization's Forms 990, Return of Organization Exempt from Income Tax, for the years ending September 30, 2018, 2017, 2016, and 2015 are subject to examination by the IRS, generally for three years after they
