East Side Learning Center (ESLC) tutored 445 children this FY through the commitment of 295 community volunteer tutors and 28 part-time paid educators Together they provided 21,045 hours of one-on-one tutoring for the children We have defined 30 hours of tutoring as the benchmark for our evaluation and data purposes Ideally, if a child is able to regularly receive tutoring for 45-minutes per day, four days per week during the school year, the child could reach 50 or more hours of support and make greater gains Our criteria for success includes 1) Kindergartners are ready for first grade reading They automatically recognize upper/lower case letter names and sounds, a minimum of thirty kindergarten sight words, have an ability to rhyme, use phonological awareness, print his/her name (Note In 2015-16, 95% (170 of 178) of kindergartners became ready for first grade reading if they attended 30 or more hours of tutoring) Our success with kindergarten is significant (2) Students in grades 1-3 will improve reading performance with the focus on reaching grade level reading They will achieve at least an 8-point DRA gain when a student attends 30 or more hours of tutoring This gain is currently monitored through the student's progression within the McGraw-Hill Guided Reading curriculum which is correlated with the Developmental Reading Assessment (DRA) (Note In 2015-16, 57% (60 of 106) 1st graders, and 85% (34 of 40) 2nd and 3rd graders reached their ESLC reading goals if they attended 30 hours or more of tutoring) To ensure children make at least an 8-point DRA gain, progress is monitored after every 13 hours of tutoring received, to determine if additional interventions are necessary
