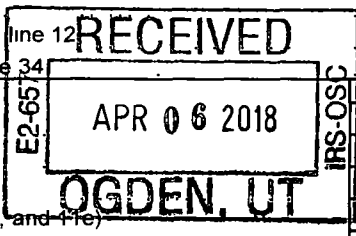

In fiscal year 2017 our facility located in Tavernier, FL served 623 uninsured patients with incomes at or below 200% of the Federal Poverty Level. We continue to focus on primary care within the clinic and utilize Healthcare Safety Net volunteers for secondary, tertiary and ancillary care needs. The Good Health Clinic arranged for approximately 2,350 such visits. Laboratory and diagnostic testing and imaging continue to be available to our patients at no cost through community partnerships.
