Specifically, CASA recruits, trains, and supports caring community volunteers (Advocates) who are partnered with children, ages 0 to 18, who are under the protection of the Juvenile Court because their parents can't or won't take care of them. Advocates support their children in many ways. They visit weekly; identify social, emotional, physical, developmental, and educational needs; ensure needs are met in a timely and appropriate manner; monitor well-being and safety in their home placements; oversee and support academic progress; engage their children in enrichment activities; facilitate information sharing among professionals; write reports to the Court to help guide the judges' decision making; and provide consistent support during traumatic events and transitions, such as changes in home placements, schools and foster families. Special Advocates are often the only consistent adults spending time with and advocating for these children during the entire time they are in the foster care system. Special Advocates focus on the needs, comfort, and happiness of the children, helping them to have as normal a life as possible under traumatic circumstances.
