They visit weekly; identify social, emotional, physical, developmental, and educational needs; ensure needs are met in a timely and appropriate manner; monitor well-being and safety in their home placements; oversee and support academic progress; engage their children in enrichment activities; facilitate information sharing among professionals; write reports to the Court to help guide the judges' decision making; and provide consistent support during traumatic events and transitions, such as changes in home placements, schools and foster families.
