The Board of Trustees reviews the President's performance on an annual basis. Board of Trustee Members complete and submit a questionnaire on the President's performance to the Chairperson of the Board of Trustees. The Chairperson calls a meeting of the Board of Trustees Executive Committee to review and discuss the results. The Executive Committee authorizes the Chairperson to meet with the President to discuss the findings and comments regarding the President's performance and to discuss compensation. Prior to the execution of an employment contract, the Board of Trustees, acting through its compensation committee, retains an independent compensation consulting firm that performs a compensation study which considered the intermediate sanctions provisions of Internal Revenue Code Section 4958 (IRC 4958). Based on the independent compensation consulting firm's work, a certification is issued to CRT's Board of Trustees indicating that the compensation provided under the employment contract is considered reasonable under IRC 4958. Upon completion of the compensation analysis, a recommendation is then presented to the Board of Trustees for a final action by voting to approve the recommendation.</p>
