THE AMOS HOUSE PROGRAM WAS STARTED IN 1986 BY FIVE AREA CHURCHES THAT RECOGNIZED AN UNMET NEED IN THE NEW YORK/CONNECTICUT AREA TO HELP HOMELESS FAMILIES MOVE TO PERMANENT HOUSING AND IMPROVE THEIR LIVES. THE FOUNDERS FELT THAT HOMELESSNESS WAS THE RESULT OF A VARIETY OF ISSUES, AND EACH SITUATION WAS UNIQUE. THEREFORE, THEY STRUCTURED A PROGRAM THAT MET THE INDIVIDUAL NEEDS OF EACH FAMILY AND RECOGNIZED THAT ONCE IN PERMANENT HOUSING, THESE FAMILIES WOULD BECOME VALUABLE CONTRIBUTORS TO SOCIETY. CENTERPIECE OF THE AMOS HOUSE PROGRAM IS A RESIDENTIAL FACILITY IN DANBURY THAT IS ADAPTABLE FOR FAMILIES OF VARIOUS SIZES.
