

THE PROJECT WAS COMPLETED ON DECEMBER 31, 2006 AND CONSISTS OF A 41 UNIT APARTMENT COMPLEX LOCATED IN BRIDGEPORT, CONNECTICUT. OCCUPANCY (RENTAL OF UNITS) BEGAN ON FEBRUARY 1, 2007. CONSTRUCTION OF THE FACILITY WAS FUNDED BY A U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) CAPITAL ADVANCE UNDER THE PROVISIONS OF SECTION 202 AND A GRANT FROM THE STATE OF CONNECTICUT DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT (DECD). IN RETURN FOR THE FUNDING, HUD AND DECD REQUIRE THE ORGANIZATION TO MAINTAIN THE PROJECT AS LOW-INCOME ELIGIBLE FOR A PERIOD OF 40 AND 20 YEARS, RESPECTFULLY. THE PROJECT IS REGULATED BY THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) AS TO RENTAL CHARGES AND OPERATING METHODS.
