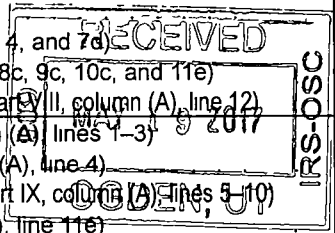

In the 2016 reporting period, Caregiver's Helper, Inc provided treatment foster care and related services to 94 at-risk children, adolescents and youth between the ages of birth to 21 years. Some of the significant accomplishments of Caregiver's Helper, Inc during the report period include (a) provided children in agency care, from repeat abuse and neglect incidents, (b) prevented and or decreased high risk behaviors such as suicidal/homicidal and run away tendencies, (c) provided children access to public education, structured after-school recreation and child development services, depending on child's age, (d) implemented case plans as set forth, (e) encouraged and facilitated family contacts and reunification plans, (f) prepared the children who cannot reunify, for adoption and/or independent living in the community, (g) provided in-class independent living skills training to older teens (16-18 years), in preparation for life after foster care (continued on Schedule O)
