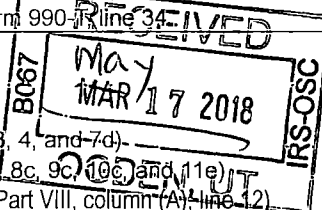

In the 2017 reporting period, the organization served 105 high risk children between the ages of 0-21 years in it's foster care program. The children came from all walks of life and backgrounds. Some of the key accomplishments of the organization in the reporting period were, (a) protecting the children in our care from being abused or neglected or becoming dependent again (b) Reduction of high risk self-harming behavior through ongoing education, counseling and crisis management. Some of the behaviors we successfully helped decrease were, drug use, sexually acting out, poor school attendance, fighting, failing grades, suicidal attempts, lying, stealing, etc (c) Provided support services such as latch key, after school daycare and summer programs to help build good social skill and self-esteem (d) Worked collaboratively with custodial agencies to ensure children return home in a timely manner and safely (See Sch O)
