ATHLETIC PROGRAMS ARE SUPERVISED BY TRAINED INSTRUCTORS TO HELP KIDS IMPROVE THEIR PHYSICAL FITNESS AND CONFIDENCE, INTRODUCING KIDS TO COMPETITION IN A RESPECTFUL AND NURTURING ENVIRONMENT. IN 2019, THE ATHLETICS DEPARTMENT SERVED OVER 655 CHILDREN AND TEENS. STATEMENT ABOUT NEW SITES: DUE TO A MAJOR CONSTRUCTION PROJECT THAT STARTED IN JUNE 2019, ALL PROGRAMS OPERATED IN OFF-SITE ALTERNATE LOCATIONS. THE SUMMER CAMP OPERATED OUT OF THE ORTHODOX CHURCH IN OLD BROOKVILLE. STARTING IN FALL 2019, WE OPERATED THREE OFF-SITE ALTERNATE LOCATIONS FOR OUR AFTERSCHOOL PROGRAMS - LOCUST VALLEY REFORMED CHURCH AND BAYVILLE COMMUNITY CENTER FOR K-5TH GRADERS AND ST. PATRICK'S CHURCH IN GLEN COVE FOR GRADES 6-12.
