 SEE SCHEDULE O - SMALL BUSINESS LENDING AND TECHNICAL ASSISTANCE COMMUNITY CAPITAL BEGAN WORKING WITH SMALL BUSINESS OWNERS IN 2003 AND RECEIVED SBA CERTIFICATION TO OFFER MICRO LOANS IN 2007 SINCE THEN, COMMUNITY CAPITAL HAS MADE OVER \$4 MILLION IN LOANS TO OVER 200 BUSINESS AND HAS EMERGED AT THE LARGEST NONPROFIT LENDER TO SMALL BUSINESSES IN THE HUDSON VALLEY MOST OF COMMUNITY CAPITAL'S LOAN CLIENTS ARE LOW INCOME, WOMEN AND/OR MINORITY BUSINESS OWNERS WHO LACK ACCESS TO CONVENTIONAL BANK FINANCING DUE TO FACTORS SUCH AS LOWER CREDIT SCORES, LESS TIME IN THE BUSINESS AND LACK OF COLLATERAL COMMUNITY CAPITAL ADDRESSES ALL OF THESE CHALLENGES BY APPLYING FLEXIBLE AND INNOVATIVE UNDERWRITING STANDARDS AS WELL AS A SUITE OF ONGOING, WRAP AROUND TECHNICAL ASSISTANCE PROGRAMS TO SUPPORT ITS LOAN CLIENTS START-UP AND EXISTING BUSINESSES MAY APPLY FOR LOANS BETWEEN \$1,000 AND \$50,000 AND CERTAIN BORROWS MAY QUALIFY FOR UP TO \$250,000 IN THE FISCAL YEAR ENDING JUNE 30, 2016, COMMUNITY CAPITAL'S SMALL BUSINESS MICRO LOAN PORTFOLIO WAS VALUED AT OVER \$1.3 MILLION FURTHERMORE, IN FY2016 ALONE IT PROVIDED OVER 3,000 HOURS OF TECHNICAL ASSISTANCE, BUSINESS PLAN REVIEW, WORKSHOPS, NETWORKING AND MENTORING COMMUNITY CAPITAL IS PROUD TO REPORT THAT AFTER FOUR YEARS IN BUSINESS, 89% OF ITS LOAN CLIENTS ARE STILL IN BUSINESS AS COMPARED TO A NATIONAL AVERAGE OF 50 PERCENT IT BELIEVES THAT THESE OUTCOMES ARE A DIRECT RESULT OF THE HIGH QUALITY, FREE TECHNICAL ASSISTANCE PROGRAMS THAT NOT ONLY ENABLE ITS CLIENTS TO SUCCEED BUT THRIVE COMMUNITY CAPITAL OPERATED A SMALL CONSUMER LOAN PROGRAM FOR IMMIGRANTS AND REFUGEES THESE SMALL DOLLAR LOANS (TYPICALLY NOT IN EXCESS OF \$2,500) WERE DESIGNED TO HELP OUR CLIENTS BUILD CREDIT, ENROLL IN EDUCATIONAL TRAINING AND ACCESS WORKFORCE DEVELOPMENT PROGRAMS THE ORGANIZATION HAS CEASED CONDUCTING THIS PROGRAM, ANY REMAINING ACTIVITY HAS BEEN ABSORBED BY MICRO COMMUNITY CAPITAL ALSO OPERATED A PROGRAM CALLED "ADD ONE" WHICH SERVICES CLIENTS RECEIVING CREDIT BUILDER AND JOB OPPORTUNITY LOANS IN CT THE ORGANIZATION HAS A CONTRACT WITH WCC TO PROVIDE A WORKSHOP AND ONE ON ONE FINANCIAL COUNSELING FOR SMALL BUSINESS OWNERS
