THE HASTINGS-ON-HUDSON AFFORDABLE HOUSING DEVELOPMENT FUND, A NON-PROFIT 501(C)3 CORPORATION, IS ABLE TO BUILD, ADMINISTER, AND REGULATE THOSE HOUSING UNITS, BOTH RENTAL AND OWNERSHIP, AND TO RECEIVE THE NECESSARY FUNDING SUPPORT FOR THESE PROJECTS. THE DEVELOPMENT FUND'S MEMBERS INCLUDE SOME OF THE MEMBERS OF THE COMMITTEE.
