(1)Independent Living progrm (ILP) is a 15 bed program. This program offers employment opportunities for youth to work in the agency owned franchise. The youth are able to make jewelry, paintings, wreaths and flower arrangements while making revenue while buiding a resume. Payroll is deposited in the youths' bank account as they learn other valuable skills through a life coach, who oversees the program.
