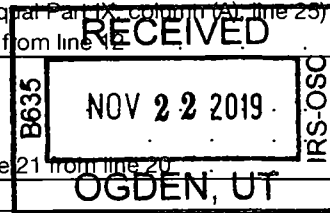

We do this through programs and projects in asset building, small business promotion, education for personal and professional development, and, economic empowerment.

Oregon IDA Initiative:
Our IDA program enables community members to save money in a bank and have that money matched with dollars from the state of Oregon. With the money community members save and the matching dollars (5:1 match rate), you must purchase an asset. Qualifying assets include home purchase or repair, business startup or expansion, education (either college or vocational), home renovation, assistive technology for people with disabilities, or motor vehicles. IDA clients must do more than be accepted into the program and save their own money to receive the IDA matching funds. All clients must complete financial empowerment training and asset-specific education to help them make the most of their savings. In 2017, 48 community members completed savings and training, and used the program to purchase 10 homes and 11 motor vehicles, to renovate 10 homes, to start or expand 8 businesses, and for 13 people to pay for college tuition or vocational education.
Note: For this program, we utilize funds from previous years' grants, including the 2014, 2015, and 2016 program years, to provide community member clients with IDAs and to administer the program.

Administration for Native Americans:
In September 2017, WSCAT received notice that we had won a 3-year, \$840,681 grant to promote small business in Warm Springs through small business education, small business IDAs, and the development of a small business incubator in downtown Warm Springs. The grant shown above is the amount provided for year one.

Northwest Area Foundation:
This grant provides salary support for WSCAT's IDA program staff and for a financial coach and counselor. The purpose of the grant is to enroll clients in IDAs, continue to serve existing IDA account holders, provide culturally specific financial education classes to community members, provide free tax filing assistance to community members, and provide financial and credit counseling to community members. In this time period, we hired a new financial counselor, enrolled 36 community members in IDAs, served 115 existing IDA account holders, provided financial skills training to 22 community members, provided financial counseling to 34 clients, and provided free tax filing assistance to 483 people.
