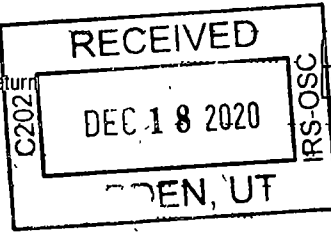

Delaware Opportunities, Inc. – EIN #16-6063879

Form 990-T is being amended to claim a refund of the tax paid for Qualified Transportation Fringe Benefits for non-deductible parking benefits that were deemed taxable under the 2017 Tax Cuts and Jobs Act, Code Section 512(a)(7). This tax was repealed on December 20, 2019 as part of the Taxpayer Certainty and Disaster Tax Relief Act of 2019.

Code Section 512(a)(7) was repealed retroactively, so the taxpayer no longer owes, and is claiming a refund of the tax paid for 2018.
