ADC's culturally competent business development services and its partnerships with crucial funding sources have directly contributed to the surge in African-owned businesses throughout Minnesota. In addition to ongoing technical assistance, ADC offered 4 start-up business workshops in the Twin Cities and 2 in Greater Minnesota (Willmar/St. Cloud and Rochester) in 2016. In 2016, more than 96 business class graduates participated in workshops in the Twin Cities and Greater MN. After completion of the workshop, clients ready to start their businesses engage in one-on-one guidance with ADC's business lenders. In 2016, ADC made 28 projects, 44 loans, leveraged over \$775,281 with a total project cost of \$1,470,500, created 104 jobs and 491 retained jobs (Total jobs 594). Additionally, ADC holds "Homestretch" workshops the first Saturday of each month for first-time home buyers in the twin cities and in greater Minnesota as well as financial literacy consulting throughout the year in Minnesota. In 2016, 291 people successfully completed these workshops and financial counseling (Homeownership education - 192, Counseling - 164, Financial Literacy - 109).
