Fort Webb Elderly Housing LLLP primary activity is to operate and maintain 36 apartments and a community building in accordance with a HUD grant made to the filing organization for low-income elderly residents in the Bowling Green-Warren County community. The Fort Webb Elderly Housing LLLP will also own, operate, and lease the units to targeted population residents.

PART IV, LINE (1), COLUMN (b) - PRIMARY ACTIVITY

Fort Webb Development Corporation primary activity is to participate in financing, promoting, and managing a 36-unit apartment complex in accordance with a HUD grant made to the filing organization for low-income elderly residents in the Bowling Green-Warren County community. Fort Webb Development Corporation will manage the apartment and monitor the HUD grant procedures as the general partner in Fort Webb Elderly Housing LLLP.
