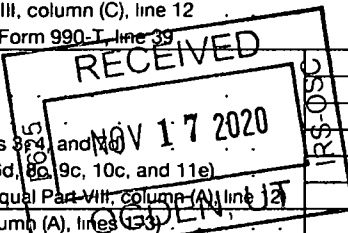

DV LEAP is the only nonprofit in the US dedicated solely to providing pro bono legal appeals to survivors of domestic/interpersonal domestic violence in Washington, DC and across the nation. Since its founding in 2004, the organization has remained steadfast in its mission to provide justice and safety for survivors of domestic violence (DV) and their children through access to the appellate court system. Protection from abuse, empowerment of victims, and improvement of the law are achieved through: 1) appellate litigation with pro bono law firm partners; 2) consultations and technical assistance provided to survivors, lawyers, and other advocates; 3) trainings for judges and attorneys; and 4) collaboration with other DV organizations to change policy and the law.
