Each year, millions of Illinoisans face serious legal problems because they cant afford a lawyer and free legal aid is scarce, even for those who qualify Illinois Legal Aid Online (ILAO) tackles the supply-and-demand problem for free legal services in the most cost-effective way possible by leveraging technology to educate and help more people Last year, ILAO served nearly 3 million people in need of legal assistance with 24/7 access to easy-to-use legal resources, reliable referrals to free or low-cost legal aid, and help understanding and preparing court forms ILAO also enables legal self-help centers, located at courthouses and libraries across the state, to provide individuals easy access the help they need in times of crisis Because the information that people need and the ways that they access it have changed over time, ILAO recently developed a brand new technology platform and website, IllinoisLegalAid.org, which was launched on Aug 1st, 2016 The new site is a lifeline for Illinois residents who cant afford a lawyer and who are facing critical legal problems like domestic violence, mortgage foreclosure, unemployment and much more It connects and serves the needs of the entire legal community, including pro bono and legal-services attorneys, court professionals, social service agencies and the public ILAO addresses peoples need for answers and solutions to their problems by simplifying the paths they take to reach the best available resource for their legal problems The new online Get Legal Help feature on IllinoisLegalAid.org presents people with a range of options for help, information, and referrals to lawyers and serves as a statewide triage system to seamlessly connect them to the most appropriate resource or service for their problem It helps people to educate themselves through plain-language information, enables lower-income Illinois residents to resolve their civil legal problems in the most effective way possible, and facilitates participation by pro bono attorneys Not knowing how to complete required forms is a big barrier to justice, especially for people who dont have a lawyer One of the most impactful services provided by ILAO is a comprehensive online library of interactive court forms and legal documents that make it easy for self-represented persons and pro bono lawyers to accurately and efficiently prepare legal forms and documents Last year, ILAOs interactive form preparation system was used over 35,000 times to create accurate, legible forms that helped people solve problems related to child support, eviction, debt collection and more
