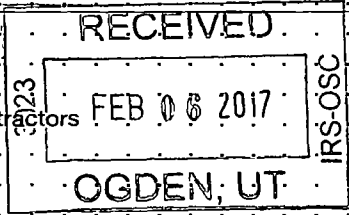



The Hampton Roads Workforce Development Corporation was formed to function as a component unit of Opportunity Inc of Hampton Roads (Opplnc), a local governmental authority chartered under the laws of Virginia. Opplnc is the staff and fiscal agent to the Hampton Roads Workforce Development Board, one of 15 Federal Workforce Areas in Virginia designated by the Governor of Virginia to fulfill the requirements of the Workforce Innovation and Opportunity Act of 2014 (previously the Workforce Investment Act). The Corporations sole purpose is to be able to receive tax deductible contributions from businesses and individuals and to receive grants from Foundations. The contributions and grants are usually restricted for a special purpose as determined by the Board of Directors, Opplnc and or the Workforce Development Board and are the awarded to Opplnc. Currently, all members of the Board of Directors of the Corporation are comprised of the Chairs and Vice-Chairs of the Workforce Development Board and its committees, in accordance with its bylaws, and the President/CEO of Opplnc.
