The population we serve are uninsured, medically indigent, homeless women and children living in poverty, and staying in the Salvation Army Center of Hope shelter. Our clinic is located within the shelter and embedded within the population of homeless women and children with the most need for healthcare, yet with the least access. 75% of clients do not have Medicaid. 85% have income less than 100% FPL. Without money they cannot afford fee-for-service health facilities. Without Medicaid they cannot access the network of Medicaid providers and services. For the majority of shelter residents and our clients, our free clinic is truly their only source of healthcare. This year homeless women increased 32% in Mecklenburg County. Homeless families increased 57% over the past five years. We provided care to 935 unique clients. 30% were children. Half of these children were between the ages of 0 and 5 years old. 68% of these infants, toddlers and pre-schoolers did not have Medicaid. Total clinic visits exceeded 4,000, as clients visited an average of 4 times. Our services delivery model is quite unique in several ways: 1) Location. Located within the population that needs healthcare the most, 2) Ease of access. Our clinic is open Monday through Friday, from 9:30AM to 6:30PM, 3) Ease of use. No appointments are needed. Clients simply walk-in, sign-in and are seen by nurses and providers. A provider was available 63% of the days the clinic was open, 4) All services are free. Recognizing our clients inability to pay, all services are provided totally free of any charges, including prescriptions, 5) Critical mass. Annually more than 60% of those in shelters will stay at the Center of Hope. All can access the clinics free services simply by showing their shelter ID, 6) Global health perspective. Shelter stay of 4 to 6 months offers a short window for care. All issues have to be addressed simultaneously rather than one-at-a-time. 7) Early Detection and Prevention. Holistic approach supported by nursing and provider care addresses existing acute issues, detects other issues percolating below the surface, identifies harbingers of issue onset and prevents other issues from occurring. 8) Continuity of care. Rather unique for such a transient population, clients visit the clinic an average of four times during their shelter stay for issue follow-up, monitoring, prescriptions, health information and to address new issues that occur. In addition to in-clinic services, we engage the general shelter population in health and wellness through a variety of outreach activities like discussion groups and special events. The purpose of these activities is to bring hard-to-source services to the clinic (mammograms and dental care) and to enlist active participation in health and wellness to motivate first-time clinic visits. Topics included HIV Prevention, Breast Health and Cancer Prevention, asthma and allergies and hypertension. Beyond these core health issues, other topics with broader appeal and indirectly related to health and wellness were Zumba, self-defense, eating healthy, parenting, avoiding abuse and riding public transportation. At all discussion groups, blood pressure readings are offered to those that had not yet visited the clinic. High BP readings provide the platform to extend an invitation to visit the clinic for a check-up and care. A network of collaborative partners deliver services beyond the clinics capabilities. Our arrangement with these partners is to have their services provided free to our referral clients, or if there is a charge to bill the clinic for payment. Both clinic and collaborative partner services are fully integrated and seamlessly delivered to optimize continuity of care and minimize abrupt hand-offs or interruptions in care. Shelter Health Services successfully renewed its Level III accreditation through the North Carolina Association of Free Clinics, the highest level of accountability for free clinics, and certified charity status through the BBB.
