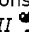


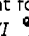




There was unrelated business income in the years ended February 28, 2018 and February 28, 2017 which resulted in a tax expense of \$118 and \$236, respectively. The Organization follows the Accounting for Uncertainty in Income Taxes accounting standard which requires The GrowHaus to determine whether a tax position (and the related tax benefit) is more likely than not would not be sustained upon examination by the applicable taxing authority, based solely on the technical merits of the position. The GrowHaus believes it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are significant to the financial statements. The GrowHaus's tax returns for the years ending February 28, 2018, February 28, 2017, February 29, 2016 and February 28, 2015 are subject to examination by the IRS, generally for three years after filing.
