AS PART OF THE PCHP, THE HOME VISITATION PROGRAM SERVED 60 CHILDREN AND THEIR FAMILIES (INCLUDING SPANISH SPEAKING FAMILIES) THROUGH AN INTENSIVE TWICE WEEKLY, TWO YEAR HOME VISITATION PROGRAM THAT BEGINS WHEN THE CHILDREN ARE TWO YEARS OLD. THE PURPOSE OF THESE HOME VISITS IS FOR THE HOME VISITOR TO MODEL FOR THE PARENT THE BEST PRACTICES OF PARENTING WITH AN EMPHASIS ON LITERACY INTERVENTION. HOME VISITORS SERVED 60 FAMILIES THROUGH 23 WEEKS OF VISITATION AND 2,760 VISITS PER YEAR.

THE EDUCATION MENTOR PROGRAM (EMP) EXTENDS THE PCHP HOME VISITATION PROGRAM BY PROVIDING A VOLUNTEER MENTOR WHO IS PAIRED WITH A CHILD WHO HAS GRADUATED FROM THE PCHP AT AGE 4 AND WHO HAS ENROLLED IN SCHOOL. THE MENTORING IS COMPLETELY SCHOOL BASED, MENTORS WORK OUT A SCHEDULE WITH THE TEACHER FOR WEEKLY VISITS OF THIRTY MINUTES TO AN HOUR WITH EACH CHILD. THE PURPOSE OF THE MENTORING PROGRAM IS TO BE A CONSISTENT PRESENCE IN THE CHILD'S LIFE AND TO HELP THE CHILD REALIZE HIS OR HER POTENTIAL IN.
