Form 990, Part III, Line 4a:

The Cops n Kids Youth Center supports neighborhood at-risk youth and their families by providing high quality afterschool and summer camp programming. Their mission is to instill personal values through programs that empower youth and families to experience healthy successful lives. The Youth Centers vision expands the lead agency's mission to support community by creating opportunities for youth and their families to experience daily stability towards self-sufficiency. Frequent exposure to high quality programming that reinforces the power of education and personal values is critical to changing the cycle of poverty. Management proactively collaborates with local and county-wide organizations to respond to community needs and support a more healthy and vibrant community.

Form 990, Part III, Line 4b:

The Health Federation of Philadelphia (HFP) launched the MARC (Mobilizing Action for Resilient Communities) program and brings together 14 communities committed to building resilience and addressing early childhood adversity through the application of Adverse Childhood Experiences (ACEs) science, language and data. Each community was awarded a grant to expand their work. A grant was awarded to the Local Community Housing Corporation (LCHC) as the fiscal agent with Peace4Tarpon as the facilitator of the program. Peace4Tarpons mission is to promote a trauma-sensitive community and foster healing.

Form 990, Part III, Line 4c:

The Local Community Housing Corporation develops, acquires and manages affordable housing. The agency owns four private market rate rental apartments. In 2010, LCHC co-developed Oak Ridge Estates, LLC apartment complex with forty-one apartments for residents with under 60% of median income and twenty-one public housing apartments. In 2016 LCHC co-developed The Villages at Tarpon, LTD apartments with 95 units designated for senior residents with three properties throughout the City of Tarpon Springs.
