### **Form 990, Part III, Line 4a:**

Building relationships across religious and racial lines. 400 participated in a 3 month relationship building process. This process involved training hosts to run house meetings. During the pandemic these "house meetings" were held virtually over zoom and similar platforms. 54 house meetings occurred with an average of 7.5 people attending each meeting. During the house meeting the host leads a discussion in which participants share stories of community problems impacting themselves, their family, and their friends. This process resulted in gathering of stories related to organization's two priority issues: criminal justice reform and housing for people living with mental illness. Participants were free to share other community concerns as well. These stories provided context to continue the research into solutions for these community problems. These leaders continued relationship building throughout the year at various organizational meetings and on their own. In addition, staff conducted more than 1,000 1-1 conversations to strengthen relationships.

When solutions were adopted, follow up meeting were held with experts to assess the impact of those solutions.
