We are an exempt organization which provides necessary services at no cost to the communities and counties with which we are associated. By being exempt, we are able to provide better services to the foster children who are in our care and in our communities.

Form 990, Part III, Line 4a - Program Service Accomplishments

2018 was a year of continued vision and growth for Dogwood Ranch and it's programs. We have continued to provide full time, long term, family based care to multiple youth who are in the foster care system. We are pleased to report our youth continue to discover new ways to manage their lives in a healthy and safe environment, now that they are out of the abuse/neglect environments that brought them to foster care initially. Dogwood Ranch continues to provide ongoing support, family connections, and independent living skills support to well over 75% of the young people who formerly lived with one of our Dogwood families prior to aging out of the system.

Our equine therapy program, Healing Reins, continues to expand it's reach and in 2018 served 78 unique clients, holding just under 200 sessions throughout the year. The majority of our clients are kids and youth who have experienced abuse and neglect, and who are formerly or currently in the foster care system. In many cases, traditional therapy has not been effective in assisting these individuals with the intense trauma of their childhood. These individuals, while working with our licensed therapist, equine specialist and incredible herd of horses, are seeing tremendous results in their ability to process traumatic events and overcome the challenges they have faced in their early years of life. Many report that they are now able to think more clearly, have more control over their emotions, and foster parents report that their children are much better able to manage their challenging behaviors than before

equine therapy. In addition to serving foster children through this program, we also offer specialized services - free of charge - to our local military veterans and their families who may be struggling with Post Traumatic Stress related issues or the challenges that face our military families in all phases of deployment.

Additionally, in 2018 Dogwood Ranch was able to break ground on two new homes that will house our Transitional Living Program. This program will serve former foster youth who are in crisis including those who are homeless, living in dangerous situations, being sex trafficked, etc. This program is set to officially open in 2019 and once completed will serve 4 young adults at a time for up to a year.

In regards to our overall community reach, we continue to partner with multiple local agencies by way of referrals, support and combining fund raising and awareness efforts. Additionally, our CEO continues in her role as contracted foster parent trainer of the State of MO allowing her the opportunity to train and mentor new foster families as they go through their licensing process. Our CEO also continues to serve on a Governor Appointed Foster Parent Advisory Board where she is the Southwest Missouri representative.
