2019 held a lot of accomplishments and goals met for Dogwood Ranch. We continue to provide long term family-based care to multiple young people in the foster care system. We are pleased to report that our youth continue to grow and succeed in meaningful ways as they learn to trust their new families, thereby giving them the stability needed to heal. Dogwood Ranch continues to provide ongoing support and family connection to almost 80% of the youth who have lived previously with one of our Dogwood families, prior to aging out of the system.

Our Equine Therapy Program, Healing Reins, expanded its client base in 2019 conducted just under 300 sessions throughout the year. The successful evidence-based counseling program primarily serves high trauma kids and individuals including foster children and our veteran population. For many of our clients, traditional talk-based therapy has not been effective. Utilizing this less traditional approach allows for many of

our clients to start healing more quickly and effectively than traditional modalities. Many of our clients report that after having completed our 12 week program they find they are better able to cope with their traumatic histories, and have improved relationship skills such as learning to trust and communicate more effectively. Most of our clients either receive scholarship money to help cover the cost of their sessions or the sessions are done pro bono (as is the case with our military veterans).

Additionally, 2019 brought exciting growth to the ranch with the addition of 2 new small homes that were built on our property. These homes house our newest program called The Haven, which provides safe housing and intensive mentor ship for former foster youth who are in crisis (homeless, being trafficked, living in a dangerous situations, etc). The first home was completed in October 2019 and immediately housed a young lady (who had previously aged out of the foster system) and her infant daughter who were homeless and living out a vehicle prior to coming to our program. The second home was approximately 50% completed at the end of 2019. We anticipate great results out of this program.

Our overall community reach continues to remain steady and consistent. We continue to partner with multiple agencies by way of referrals, support and combining fundrasing/awareness efforts together. Additionally, our CEO continues her role as a contracted foster parent trainer for the State of MO allowing her to train and mentor new foster families as they go through the licensing process. Our CEO also continues to serve on a Governor Appointed Foster Parent Advisory Board where she represents her region in SWMO.
