Project Access Northwest collaborates with the health care community to open doors to medical and dental care for the low income individuals through a distributed network of donated care that assures appropriate access to medical and dental specialty care services

Project Access Northwest (PANW) links low income uninsured and underinsured King, Kitsap and Snohomish County patients to volunteer specialty providers in PANW's distributed network Working with community health centers and free clinics patients, PANW assures access to needed specialty care by providing care coordination services With our care coordination, our patients have a better than typical no-rate (about 5% compared to a typical rate of 30+%), are more likely to show up on time and be prepared to engage with the specialist on his/her health care In 2015, 2,841 patients were appointed by PANW for medical services in our three county service area Our patients were served by approximately 1,500 licensed clinicians

Project Access Northwest (PANW) links low income uninsured and underinsured King and Snohomish County patients with volunteer dental providers in PANW's network of care In King County, PANW's focus is on complete oral specialty care services, oral health clearance prior to organ transplantation and dentures In Snohomish County, the focus includes oral care services including restorative care In partnership with the community health centers and free clinics, Swedish Community Specialty Clinic and dentists in private practice, PANW provides care coordination services to assure patients are eligible, have a qualifying oral health need and have the pre-visit dental treatment plan In 2015, 2,711 were appointed by PANW for dental services and served by close to 100 dentists and dental clinicians

Project Access Northwest's Premium Assistance Sponsorship Program was developed late in 2013 Enrollees were able to purchase health care insurance in the Washington State Health Benefits Exchange, not eligible for AppleHealth (Medicaid) and unable to afford the remaining monthly premium even after federal subsidy via tax credits have been applied In 2015, we were able to enroll and maintain health insurance for 142 covered lives for the policy year that began in January and ended in December, 2015
