A QUORUM SHALL REQUIRE AT LEAST 5 DIRECTORS AUTHORIZED TO VOTE AND MAJORITY OF PRESENTED DIRECTORS HAVE TO AGREE. THE BOARD MEETINGS REQUIRE A QUORUM TO TRANSACT BUSINESS. A QUORUM MUST BE PRESENT FOR THE DURATION OF THE MEETING. SBA ALLOWS INTERIM VACANCIES ON THE BOARD OF DIRECTORS TO BE FILLED BY A MAJORITY OF THE REMAINING BOARD OF DIRECTORS. ANY PERSON FILLING AN INTERIM VACANCY MUST STAND FOR ELECTION AT THE NEXT ANNUAL OR SPECIAL MEETING OF THE BOARDS, WHICHEVER COMES FIRST. IF A NEW BOARD POSITION IS CREATED, IT MUST BE FILLED BY A VOTE OF THE DIRECTORS AT THE NEXT ANNUAL OR SPECIAL MEETING OF THE DIRECTORS. WHEN THE BOARD VOTES ON SBA LOAN APPROVAL OR SERVICING ACTIONS, AT LEAST TWO BOARD DIRECTORS WITH COMMERCIAL LOAN EXPERIENCE ACCEPTABLE TO SBA, OTHER THAN THE CDC MANAGER, MUST BE PRESENT AND VOTE. THERE MUST BE NO ACTUAL OR APPARENT CONFLICT OF INTEREST WITH RESPECT TO ANY ACTIONS OF THE BOARD. THE CDC BOARD OF DIRECTORS MAY DELEGATE MANAGEMENT FUNCTIONS TO AN EXECUTIVE COMMITTEE. THE EXECUTIVE COMMITTEE MUST MEET THE SAME REQUIREMENTS AS THE BOARD OF DIRECTORS BUT MAY BE APPOINTED BY THE BOARD OF DIRECTORS.</p>
