FIFTY-EIGHT PERCENT OF CLUB MEMBERS QUALIFY AS LOW OR VERY LOW INCOME (BASED ON HUD GUIDELINES), 42% QUALIFY FOR FREE OR REDUCED LUNCH PROGRAMS, AND 34% ARE FROM SINGLE PARENT HOMES OR LIVE WITH SOMEONE OTHER THAN A PARENT. BOYS & GIRLS CLUB OF LA PLATA COUNTY'S EVALUATION RESULTS DEMONSTRATE SIGNIFICANT IMPACT ON PARTICIPATING YOUTH IN DIFFERENT PARTS OF THEIR LIVES AS A RESULT OF THEIR PARTICIPATION IN CLUB PROGRAMS.
