Foster Care Awareness and Church Partnerships: In 2019, Faithbridge partnered with 61 churches and supported three 24 new church launches. Through these partnerships and awareness efforts, FaithBridge introduced 1,156 new people to foster care, which resulted in 100 new licensed families.

Child Placements and Program Enhancements: In 2019, FaithBridge received 2039 referrals for foster children and placed 245 new children in FaithBridge foster homes. In 2019, 90% of children left the care of FaithBridge with a positive departure in which they were adopted by their foster family or returned to live with a relative. Through the FaithBridge quality department, a clinical advisory team reviewed and assessed children and families that needed increased support and ensured services were obtained to meet the children's clinical needs. In addition, FaithBridge implemented an annual quality improvement plan to enhance services to the foster children and improve training for the foster families.
