**The Miami Township Community Improvement Corporation (MTCIC) received a parcel of land owned by the local government (Miami Township-Montgomery County, Ohio Board of Trustees) during Q1-2018. That parcel was subsequently sold to the Humane Society of Greater Dayton in Q2-2018 with an independent appraisal establishing transaction value. Proceeds from the sale were deposited into the MTCIC for future economic development within Miami Township.**

4b (Code ) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 3,975)  
**The MTCIC purchased a parcel of property for the purpose of facilitating the extension of a local roadway and the connection of that extended roadway to a state highway with appropriate signalization and configuration. The roadway extension is facilitating the construction of new senior housing and memory care facility within the Miami Township. The seller paid half of the survey and real estate environmental assessment work required by MTCIC. Prior commercial activities on the parcel dated back to WWII, and the assessments were required to determine the existence of any significant hazardous issues or concerns. As a result of this cost-sharing, the MTCIC received a net credit at closing.**
