Accomplishments We feed over 2000 individuals every month who are documented low income, and prove a real need for food

The Pathway Home Foundation Girls Coming Up Program and the MeMyCo Program. Teaches coaches, and mentors boys and girls from documented low income families, helping them to develop life skills enabling the children to abstain from risky behaviors that may impede them from success in school and in life.
Accomplishments We help the families who come to the food pantry with children and throughout the community, by assisting with homework, transportation, health referrals, shelter, and classes and mentoring to raise children's self esteem and by providing life skills coaching. In 2018 we helped over 244 children to improve their lives through mentoring programs.

The Pathway Home Foundation Ready for Work, and Women Ready for Work programs helps low income, needy men and women to develop skills to work in today's workforce, by providing coaching, training, career guidance and job searches. Entrepreneurial education and and business start up workshops are provided to men, women and children who live at or below the poverty line. Transportation is also provided for health care referrals and to job interviews when needed.
Accomplishments The Ready for Work program helped 23 men receive work in 2018. The Women Ready for Work program helped 31 women with children who were experiencing poverty to receive food, clothing, career and job search assistance. 29 women are now gainfully employed.
