Community Impact Program Grants - United Way of Geauga County works to address the critical needs of the Geauga community by supporting programs focused on solutions in education, income and health. Funding goes directly to programs which address these focus areas and are making a positive impact on the lives of those in our community.

4b (Code:) (Expenses \$ 602,937 including grants of \$ 0) (Revenue \$ 146,330)
Community Planning and Information and Referral - In addition to funding programs in the community, United Way of Geauga County provides direct service programs that benefit the greater good within the community. Information and referral services are provided by the United Way 211 program. The program, which is available 24 hours per day 7 days per week, assists callers to assess and clarify their problems and needs. Once the needs of the caller are identified, the trained specialist will determine the most appropriate service provider and follow through with the development of a plan of action. As a result of their training, knowledge and exhaustive database of service providers the plan of action and the referral allow the caller to very quickly and efficiently gain access to the services they need.
211 is a valuable resource in the community but it also serves as a real time planning tool to assess emerging issues and service gaps which may exist in a community. This aids the process of planning and prioritizing how the grants will be made using community volunteers to fund community solutions/programs.

In early 2012, a shooting occurred at a high school in the community of Chardon. The shooting left three children dead and three wounded, one severely. United Way of Geauga County and United Way of Greater Cleveland (34-6516654), the parent organization, set up a volunteer managed fund which was to be used to help the immediate needs of the families as well as to help the community heal from this terrible tragedy. A charitable class of the Chardon community was identified and the fund was known as the Chardon Healing Fund.
