Serving Our Children is dedicated to the concept that all students are capable of learning and excelling in life, and that all students, regardless of income or socioeconomic status, should have access to a quality education. To this end, we believe parents should have access to quality public schools, quality charter schools, and quality private schools. SOC is focused on ensuring that low income DC families have access to scholarships to enable them to send their children to private schools as an option.

Serving Our Children processed 3,244 applications from qualified District of Columbia families in their quest for an Opportunity Scholarship that would provide a choice to these parents in their effort to meet the needs and expectations fo their young scholars. SOC awarded 2,614 scholarships after vetting these applications to ensure the awardees meet the requirements of the SOAR Act, to wit, DC residency and income ceilings. During the reporting period, SOC placed and issued scholarships to 1,718 students enrolled in grades K through 12 at private schools in the District. Scholarships amounts were capped at \$8,633 for grades K through 8 and \$12,981 for grades 9 through 12. The SOAR Act also provides for academic assistance to our students in the form of tutoring performed by Performance Management Services at our participating schools. All of our OSP students are eligible for this assistance.

Serving Our Children administered the Hispanic Education Inperative Fund (HEIF) on behalf of the Crimsonbridge Foundation. HEIF provides up to \$3,000 in scholarships to Hispanic students in the District to attend a private Catholic school of their choice.
