Ravenwood \$500 - purchased household items for homeless families moving into Ravenwood Housing and gift cards to residents for food and necessities.

Next Step \$500 - purchased a single bed, a dresser, and a nightstand for clients room for those aged 18 - 24 who were homeless.

GMHA \$500 - purchased toilet paper, personal hygiene care products, dish soap, paper towels, and cleaning supplies for those entering GMHA housing.

Geauga Faith Rescue Mission \$500 - subsidized rent for 2 individuals who were homeless

Lake-Geauga Habitat for Humanity \$500 - funded the ADA compliance modifications for a family of five who has a daughter with special needs.

Pleasant Hill Home \$500 - purchased bedding including quilts, mattress pads, and sheets for residents rooms. Residents are low income senior citizens, persons with disabilities, and persons needing temporary housing
