WE ENCOURAGE STUDENTS TO REALIZE THEIR INHERENT VALUE SO THAT THEY CAN ALSO RECOGNIZE THE VALUE OF COMMUNITY AND THEIR ABILITY TO BE POSITIVE INFLUENCERS WITHIN IT. STUDENTS MOVE FROM SURVIVAL MODE TO A STABLE AND SAFE CIRCUMSTANCE. JLT PROVIDES 14 MONTHS OF SUPPORT THAT BEGINS WITH AN 8-WEEK INTENSIVE PHASE THAT FOCUSES ON JOB SKILLS, FINANCIAL LITERACY, MANHOOD, AND AN INTERNSHIP. THESE COLLABORATIVE AND INTERACTIVE ACTIVITIES ALLOW STUDENTS TO EXPLORE POSSIBILITIES FOR FUTURE CAREERS, CONSTRUCTIVE HOBBIES, AND ENCOURAGE THEM TO BE COMMUNITY-ORIENTED.
