The standard compensation as well as the benefits package compared with the market. To date, the positions we survey include CEO, COO, CFO, VPs and Div. Directors. The market data is then shared with the compensation committee, a subcommittee of the board which is staffed by officers of the board. For the review of the CEO's performance, the results from goals which were established for the CEO at the beginning of the period are evaluated and the committee then recommends to the full board an increase in pay, if any, and a bonus, if any. Notes from the process are produced contemporaneously by the chair of the compensation committee. The CEO reviews the work performed by the compensation consultant for the positions of COO, CFO, VPs and Divisional Directors with the compensation committee and makes a recommendation to the committee for salary, bonuses, if any, and benefits within the salary ranges determined in the market place. The compensation committee, in consultation with the CEO, then approves the CEO's recommendation. The performance of the COO, CFO, VPs & Divisional Directors is assessed annually. Pay increases, if any take effect January 1st.</p>
