The completed surveys are then reviewed by both the finance committee & general counsel, and appropriate action is taken to remove potential or actual conflicts of interest. Every other year we hire an external compensation consultant to survey positions in the organizations with similar revenues. The standard compensation as well as the benefits package compared with the market. To date, the positions we survey include CEO, COO, CFO, VPs and Div. Directors. The market data is then shared with the compensation committee, a subcommittee of the board which is staffed by officers of the board. For the review of the CEO's performance, the results from goals which were established for the CEO at the beginning of the period are evaluated and the committee then recommends to the full board an increase in pay, if any, and a bonus, if any. The full board then meets in closed session and approves or amends the compensation recommendation. The CEO's change in compensation and benefits, if any, are effective January 1st. Notes from the process are produced contemporaneously by the chair of the compensation committee. The CEO reviews the work performed by the compensation consultant for the positions COO, CFO, VPs and Divisional Directors with the compensation committee and makes a recommendation to the committee for salary, bonuses, if any, and benefits within the salary ranges determined in the market place. The compensation committee, in consultation with the CEO, then approves the CEO's recommendation. The performance of the COO, CFO, VPs & Div. Directors is assessed annually. Pay increases, if any, take effect January 1st.</p>
