Part III - 4A Youth Development - Child Care We believe that all kids deserve the opportunity to discover who they are and what they can achieve. In addition, we believe that kids need a safe, nurturing environment in which to learn, grow, and thrive. Our School Age Child Care (SACC) programs, which care for 1,300 children in grades K - 8 at 25 sites in four communities, provide just such an environment. Our Financial Assistance Program subsidizes our fees so that everyone can afford to keep their kids safe and happy at the Y. Every year we provide approximately \$209,000 in financial assistance exclusively for School Age Child Care. YMCA SACC is far more than simply babysitting, though safety is an important element. Research has shown that the after school hours of 3:00 - 6:00 pm are the most dangerous for youth and teens, hours when they can get into trouble or when trouble can find them. Safety and peace of mind are only a small part of what we offer to our families. We help children develop relationships and make friends. At least 50% of parents recently surveyed strongly agree that after school child care programs at the Y helps their children make new friends and provide good child/staff relationships. Our after school child care programs provide an excellent opportunity to help these children build relationships. Y Child Care programs also teach and model our core values - Caring, Honesty, Respect and Responsibility - and healthy habits. We ensure that participants have access to healthy snacks and provide at least 30 minutes of physical activity every day.

Part III - 4A Youth Development - Summer Day Camp The YMCA of Montclair camp experience is a rich, learning environment with new friends, new songs, and new achievements, combined with new growth and independence. The essence of YMCA camp is the presence of supportive relationships, meaningful opportunities, and challenging activities in a physically and emotionally safe environment. Camp is a place designed for children, where they can explore and discover, important rites of passage especially for today's children. Camp nurtures curiosity, inviting creativity, which is a precursor to discovery and growth. As one mom wrote, "Our child was nervous to go to a new camp. It was 'far away, really big' and full of lots of new things. After less than one week at Camp, my husband and I saw a change in her that can barely be captured in words. She began waking up on her own by 6:30am so that she could get ready for her days. She bounced to the bus, made friends with bus counselors and new kids, and went off to Camp. A kid that was more of an observer in the beginning of the summer is a kid who has now met tons of new friends, has learned countless new songs, has made tremendous creative projects, and spends the weekends waiting for Mondays. She loves the theme each week, and comes home with stories about the creative activities, funny counselor moments, and amazing accomplishments she has made. She can summit the 'Space net', tell where to find a frog, teach anyone the best way to ride a mini scooter, and give great advice about how to eat picnic lunch in the shade. Most of all, her swimming skills and love for water are just outstanding. The change we've seen in just 7 short weeks is incredible. It's hard to believe summer is ending, and we cannot wait to send her back for another summer of love, laughs, and learning. Thank you so much for giving our daughter such a wonderful experience! The YMCA of Montclair's Summer Day Camp serves over 2,900 children ages 2 - 15 at ten different camps. As part of our mission to ensure that everyone can afford to come to camp, regardless of their financial circumstances, we provide over \$151,000 in Financial Assistance every year to over 200 children."

Part III - 4B Healthy Living The YMCA of Montclair is a leading voice on health and well-being. The Y brings families closer together, encourages good health and fosters connections through fitness, sports, fun, and shared interests. As a result, thousands of youth, adults and families receive the support, guidance, and resources they need to achieve greater health and well-being for their spirit, mind, and body. A great example of the Y's commitment to Healthy Living is LiveSTRONG at the Y, a special 12-week program for cancer survivors to get them back on the road to improved health through supervised exercise in a small group setting. As recent "graduates" of LiveSTRONG said, I have experienced wonderful and exciting life experiences. The LiveSTRONG program has made me feel like a new person with a new beginning. I have learned exercise techniques and use them the right way through cardio, breathing and inhalation and building up my self-esteem for working out with others. This experience has encouraged me to walk and be more active. I am now able to walk over two miles on a daily basis. More importantly, I thoroughly enjoy the walks. I have more energy and more physical confidence. I am even going to throw out my vintage Reeboks that are disintegrating and invest in a new pair of sneakers. That shows hope. I will continue to exercise. I will definitely join the Y after this program is over. I am very grateful. LiveSTRONG is not unique. Our instructors, including fitness floor staff, are trained to provide caring attention to our members, helping them meet their goals, no matter what they are or where they start. As with our other programs, membership fees are subsidized for those with demonstrated need through our Financial Assistance Program.

Form 990, Part III, Line 4c:

Part III - 4C Social Responsibility In addition to our Youth Development and Healthy Living programs, the Y is committed to providing support and resources to the community. Some of our initiatives serve a unique focus or group of people and some happen outside of the walls of our Y. We are proud to make a positive impact upon youth, families and adults in our community through these initiatives. Every year the YMCA of Montclair offers SPLASH Week, a FREE water safety program offered each spring to help people of all ages, especially children, learn basic swimming skills and water safety practices. Learning water safety and swimming skills helps participants to be safe in and around water. This builds self-confidence and self-esteem, which carries over into other parts of life. The YMCA of Montclair is addressing the educational achievement gap in our community with ACE-Academic Camp Experience, an academic camp for children in grades 2-4. Now in its fourth year, ACE has grown from serving five children to 71. Children who were struggling before camp are surging ahead. One boy went from almost failing third grade to getting 90s and 100s on spelling, reading and language arts tests as a result of his participation in ACE, and all our students show at least some improvement in literacy, math and science from the beginning to the end of the program. The Y also collaborates with community organizations in a number of ways, including * Weekly food drive for the Salvation Army Montclair Citadel * Holiday Giving Tree * Toys for Tots * Volunteering at the Montclair Community Pre-K. In 2018, the YMCA of Montclair provided over \$485,000 in direct Financial Assistance to individuals and families in our community who are struggling and in need of a helping hand.
