The Hispanic Family Center of Southern NJ (HFC) serves 10,000 individuals annually with a cadre of bilingual and multicultural staff. The Family Counseling Clinic offers members of the community access to counselors and therapists specifically trained for working with individuals who have mental illness or substance use disorders, senior programs, youth prevention services, and energy assistance (in both Camden and Gloucester Counties).
