Good Shepherd Food Bank engages in many other activities that are nevertheless important to its core principles and mission. The most significant of these other program service accomplishments are as follows: **Cooking Matters Maine**—an outreach program that mobilizes culinary and nutrition professionals to teach cooking and nutrition classes to low-income adults, teens, and children. Classes are taught at local community centers, schools, and food pantries, and the classes provide people at risk of hunger with hands-on cooking and nutrition experience. In fiscal year 2019, the program offered 276 Cooking Matters classes and 291 store tours to more than 5,950 participants. **Critical Response Program**—The Food Bank operates a mobile food pantry to reach underserved areas of Maine. In fiscal year 2019, the Food Bank distributed nearly 240,000 pounds of food through 67 Food Mobile deliveries. The Food Bank provided grants of over \$45,000 to 220 agencies to relieve the impact that the early issuance of SNAP benefits posed during the government shutdown in the winter of 2019. Through funding provided by foundation partners, the Food Bank provided grants of over \$28,000 to 25 partner agencies to help build the necessary infrastructure to reduce food insecurity throughout Maine. **Community Health and Hunger**—the Food Bank forms partnerships with health care organizations to reduce the negative impact of food insecurity on health outcomes. Through the program, the Food Bank provides training and technical assistance for health care providers implementing food insecurity screening and referral to food resources, and supports projects that directly distribute food in health care settings for patients in need. In fiscal year 2019, the Food Bank worked with 76 sites to provide nearly 66,000 pounds of food to people who screened positive for food insecurity.

A percentage of the market value of the fund can be used every year to support the organization's mission as outlined above, while the remainder of the fund is held to appreciate in value for future use. In January 2007, GSFB transferred funds to the Maine Community Foundation (the "Foundation") to establish an endowment fund with GSFB named as beneficiary. Under terms of the agreement, a percentage of the market value of the fund ("annual spending policy") shall be paid and distributed to GSFB at least annually, or on a schedule to which the parties may from time to time change. GSFB can withdraw all or a portion of the original amount transferred, any appreciation on those transferred assets, or both, provided that a majority of the governing boards of GSFB and the Foundation approve of the withdrawal. At the time of the transfer, GSFB granted variance power to the Foundation. That power gives the Foundation the right to distribute the investment income to another not-for-profit organization of its choice if GSFB ceases to exist or if the governing board of the Foundation votes that support of GSFB (a) is no longer necessary, (b) is incapable of fulfillment, or (c) is inconsistent with the needs of the community. At June 30, 2019 and 2018, the endowment fund has a value of \$280,746 and \$80,151, respectively, which is reported in the statements of financial position as a beneficial interest in assets held by others and board designated endowment.</p>
